Equity and fixed-income funds—Class C shares (no front-end sales charge)

Applicable to CDSC

All DWS funds <1 year 1.00% >1 year 0.00%

The 1% annual fee is paid quarterly commencing the thirteenth month after investment.

Effective on or about 5/10/21, each fund's existing Class C conversion feature will change so that Class C shares will automatically convert to Class A shares in the same fund after 8 years instead of 10 years, provided that the fund or the financial intermediary through which the shareholder purchased the Class C shares has records verifying that the Class C shares have been held for at least 8 years.

Class R and R6

For Class R and R6 shares, there is no sales charge. These share classes are only available to participants in certain retirement plans. Not all share classes are available to all investors.
